## Purpose

This regulation allows the Virginia State Police to check with the National Crime Information Center (NCIC) for instant criminal history records for persons purchasing firearms. Currently this can only be done through the Virginia Criminal Information Network (VCIN). Adding NCIC gives a national capacity for background checks. Additionally, there are several technical changes made that are recommended by the Virginia State Police related to sanctions for violations by dealers and the appeals process.

This amendment provides for access to the National Crime Information Center by the Virginia State Police for instant records checks for persons purchasing firearms. It also provides sanctions for dealers who violate regulations regarding firearms purchases, and provides an appeals process for those dealers. The current system only provides for criminal history records checks in Virginia. Persons who may have a criminal record in other states would not be identified because of current limitations.

### **Alternatives**

Please describe, to the extent known, the specific alternatives to the proposal that have been considered or will be considered to meet the essential purpose of the action.

Access to the National Crime Information Center is needed to ensure that persons with criminal histories in other states cannot purchase firearms in Virginia. There are no other alternatives.

#### Family Impact Statement

This regulation expands the ability of the Virginia State Police to ensure public safety by identifying persons who should not be able to purchase firearms in Virginia because of criminal history.
