Virginia Fire Services Board (VFSB) voted, at its August 3, 2018 to replace 19 VAC Chapter 30. Regulations Establishing the Certification Standards for Fire Investigators with a link, on the VDFP website, which leads to NFPA 1033, Standard for Professional Qualifications for Fire Investigator.

VFSB has determined that the national standards will now serve as the compulsory minimum training standards for Fire Investigator. Accordingly, VDFP seeks to repeal the existing regulations via the fast track process.

The requested revisions are essential to protect the safety and welfare of citizens to ensure that fire investigators are receiving the most current training. Presently, the when training standards must be revised, the department has to seek such changes through the standard regulatory process which requires a minimum of 12-18 months for completion. This is far too lengthy of a with public and officer safety issues.
