This proposal is to reflect the fact that Big Tumbling Creek and its tributaries in the Wildlife Management Area go into Russell and Washington Counties as well as Smyth.

Section 160:

This proposal would allow stocking efforts and DWR law enforcement to better target specific areas of Chestnut Creek (Carroll County). Existing areas are difficult to access because of local geography.

Regulation proposal arose out of a need to clarify the extent to where single hook artificial lures may be used for trout in Big Tumbling Creek in order to better protect the trout fishery in that area to be more inclusive of the true extent of the Creek and it's tributaries within the area

Section 160:

Regulation proposal would better allow both the public and DWR conservation police staff to access and patrol areas of Chestnut Creek that can be fished with artificial lures only; as currently the stretch of the creek in regulation is hard to access in its entirety as defined. Would narrow the scope of stocking efforts in this stretch of creek to allow better and more focused public access.
