This regulatory change requires reduces possession limits for crayfish from 50 to 20; allows crayfish to be used for bait only in the body of water of capture; and prohibits the collection of crayfish in the Big Sandy River basin. All of these changes are found in 4 VAC 15-360-10. The change also removes a permit for minnow and chub collection and sale that has been very rarely utilized by the public.

The impetus for these regulatory changes is the Board's biennial periodic review of its Aquatics/freshwater fishing regulations. Internal staff review and consideration of subsequent public comment through the Board's regulatory development process found this change advisable based on fisheries management goals and goals for the protection of Virginia crayfish species and populations, while continuing to allow an appropriate level of collection for personal use.
