The proposed amendment to existing regulations will ensure compliance with legislation enacted by the 2006 and 2007 General Assemblies and with current immunization practices as recommended by the Advisory Committee for Immunization Practices, the American Academy of Pediatrics and the American Academy of Family Physicians (required by the Code of Virginia).

Statutory authority to promulgate these regulations is granted to the State Board of Health by §§22.1-271.2 and 32.1-46 of the Code of Virginia.

Regulations are necessary to ensure children are protected to the extent possible from vaccine-preventable diseases and to protect indirectly the health of Virginians. Legislation enacted by the 2006 Virginia General Assembly requires the regulations to be updated to reflect current immunization recommendations and also added two new required vaccines. Legislation enacted by the 2007 Virginia General Assembly added an additional new vaccine requirement. The regulations must be amended to bring them into conformance with the new legislation as well as with current immunization recommendations.

Amendments to the current regulations will:

- Update and clarify definitions;
- Update childhood immunizations required for attendance at Virginia schools and day cares to include additional required vaccines and reflect current recommended immunization practices;

- Update responsibilities of admitting officials.

The proposed regulations will ensure that children are protected to the extent possible from vaccine-preventable diseases and will indirectly protect the health of all citizens of Virginia. Disadvantages may include increased costs associated with providing additional required vaccines. Additional time may be needed for parents to obtain and providers to document required vaccines.

There are no applicable federal requirements. The proposed regulations are written in response to the Code of Virginia 32.1-46 which requires children to be immunized and also requires an annual review of the section.

Projected cost to the state to implement and enforce the proposed regulation, including (a) fund source / fund detail, and (b) a delineation of one-time versus on-going expenditures	The cost to the state will be to supply the additional doses of required vaccines to school-age children, including administration costs, for children receiving vaccines at local health departments, an on-going expense. Implementation of SB 116 in 2006 (Tdap requirement) depended on approval of funding; \$280,110/year was approved and will cover costs. In 2007, the legislature funded \$1.4 million/year to implement HB2035, which requires HPV vaccine for girls prior to sixth grade entry. This amount is expected to cover all costs. Minimal fiscal impact is expected as a result of increasing the required number of doses of tetanus, diphtheria, and pertussis containing (DTaP) vaccines from three to four. Current recommendations are for five doses and this vaccine is available at no cost to all children at local health departments. There will be very little fiscal impact as a result of requiring a second dose of mumps-containing vaccine; nearly all children already receive two doses when receiving the combination vaccine (MMR) to meet the current requirement for two doses of measles-containing vaccine. Requiring a second dose of varicella vaccine at kindergarten entry should also have minimal fiscal impact since a second dose of vaccine is currently being made available at no cost to all children under the age of 18 years at local health departments. Requiring pneumococcal vaccine for children less than two years of age (as added by SB116) is also expected to have minimal fiscal impact. Federal funds are adequate to

Projected cost of the regulation on localities	Local health departments may incur loss of revenue as a result of loss of the ability to charge for the office visit and for administration of the second dose of varicella vaccine to kindergarten students. Currently, this is approximately \$30 per dose of vaccine.
Description of the individuals, businesses or other entities likely to be affected by the regulation	Private health care providers may incur minimal additional costs for supplies to administer vaccines as well as minimal additional staff time to ensure children are appropriately vaccinated before school begins each year.

The regulations are mandated by the *Code of Virginia*. The agency believes the regulations provide the best solution in response to the law.
