Legislation enacted during the 2018 legislative session required the Virginia Department of Health to amend regulations governing newborn screening to include certain diseases: HB1174 and SB449 were approved by the Governor on March 30, 2018.

The legislation requires that the regulations governing newborn screening be amended regulations to include Pompe disease and mucopolysaccharidosis type I (MPS I). This regulatory action seeks to conform the regulations to changes in Virginia statutory law.

The amendment to add Pompe disease and mucopolysaccharidosis type I (MPS I) to the Virginia Newborn Screening System's core panel of heritable disorders and genetic diseases is consistent with the Health Resources and Services Administration's Advisory Committee on Heritable Disorders in Newborns and Children Recommended Uniform Screening Panel (RUSP). Pompe disease and MPS I were recommended to be added to the RUSP in 2015 and 2016, respectively.

The State Health Commissioner approved these amendments to the Regulations Governing Virginia Newborn Screening Services, on behalf of the State Board of Health while the Board was not in session, on August 1, 2018.
