The Virginia Department of Health (VDH), Office of Radiological Health (ORH) is tasked with regulating sources of radiation within the Commonwealth in order to protect the public from unnecessary exposure. Section 32.1-229.1 of the Code of Virginia (Code) authorizes the Board of Health (Board) to establish fee schedules for the registration and inspection of x-ray machines, as well as the licensing of radioactive materials. ORH is almost entirely funded through revenues collected according to 12VAC5-490. Since the fee schedule was last amended in 2019, significant inflation and increases in operational costs warrant the consideration of changes to the fees assessed for registrations, inspections, and licensing of x-ray machines and radioactive materials. Additionally, internal and external evaluations of ORH's organizational structure have concluded that one additional x-ray inspector position and one additional radioactive materials inspector position are needed in Northern Virginia. ORH will

consider fee increases that take into account the minimum amount of revenue required to ensure the proper oversight of sources of radiation required by § 32.1-229 of the Code.

Mandate and Impetus

ORH conducted a periodic review of 12VAC5-490 and posted the review result to Townhall on August 3, 2022. Section 32.1-229 of the Code mandates the Board maintain a program to regulate sources of radiation, as well as establish a fee schedule necessary to operate the program. After a review of the revenue generated by the current fee schedule and the program's expenses, ORH has determined that the fee schedule must be amended. Since 12VAC5-490 was last amended in February 2019, inflation has risen significantly. The cost of business operations has also increased with statewide pay raises, higher mileage rates, and higher per diem rates as some examples.

ORH took several factors into account when considering changes to the fee schedule. First, ORH used the U.S. Bureau of Labor Statistics' CPI Inflation Calculator to assess the change in buying power of the fees established in February 2019 to that of July 2022, which is the most recent data available. Second, ORH reviewed its revenues, expenditures, and anticipated new spending. ORH expects to incur several new spending initiatives and increased operational costs including, but not limited to hiring two new Safety/Compliance Officer positions, upgrading the mobile incident command/radiation laboratory, a five percent raise for state employees, and a \$1,000 bonus for state employees. The changes to the fee schedule under consideration should generate enough revenue to reduce the need to amend the fee schedule in the near future, likely for at least five years.

- c. § 32.1-229.1, which directs the Board to promulgate fee schedules for the registration of x-ray machines, the inspections of x-ray machines by Department personnel.
- d. § 32.1-229.2, which states that the fee schedule for inspections of x-ray machines by Department personnel shall include all reasonable costs of such inspections.

Purpose

As the state radiation control agency designated by § 32.1-228.1, VDH has a mandate to regulate and inspect sources of radiation in order to protect public health. ORH operations are funded almost entirely by revenues collected according to 12VAC5-490. In order to enforce the Radiation Protection Regulations found in 12VAC5-481, ORH must be able to amend the fee schedule to meet its financial obligations. ORH anticipates the proposed changes to the fee schedule may result in public comments challenging this proposal. However, § 32.1-229.2 of the Code directs the Board to develop a fee schedule that includes all reasonable costs of inspections conducted by VDH inspectors in order to minimize competition. Currently, the fee schedule for inspections conducted by VDH is lower than the fees assessed by private inspectors for identical inspections. ORH will propose the minimum fee increases necessary to maintain the regulation and control of sources of radiation required by § 32.1-229.

Substance

12VAC5-490-10 Registration fees

ORH is considering a 25% increase to the registration fees for all x-ray machines.

12VAC5-490-20 Inspection fees and inspection frequencies for x-ray machinesORH is considering a 25% increase to the fees charged for the inspection of x-ray machines by ORH personnel.

12VAC5-490-40 Application and licensing fees for radioactive materials licenses

1. ORH is considering a 25% increase to all specific license fees for radioactive materials.

- 2. ORH is considering changing the fees assessed to licensees with more than five sites to 1.5 times the specific license type fee currently in effect. The U.S. Nuclear Regulatory Commission (NRC) requires a certain percentage of sites listed on a radioactive materials license to receive an inspection. ORH Compliance/Safety Officers spend more time and effort inspecting licensees with six or more sites on a license than those with less.
- 3. ORH is considering raising the reciprocity fee from 50% to 75% of the specific license fee currently in effect. This change would improve the ability of Virginia licensees to compete for work with vendors holding a license from another NRC agreement state and operating under reciprocity at 50% of the standard license fee.

The Code of Virginia § 32.1-229.1 sets the private inspector application and annual fee at \$150. ORH is not currently considering a change to the private inspector registration fees in 12VAC5-490-50.

Alternatives to Regulation

The Virginia Radiation Protection Regulations: Fee Schedule, 12VAC5-490, remains critical to protecting the public from unnecessary radiation exposure caused by a wide spectrum of applications used in the healing arts, research, educational institutions, and industry. ORH operations are sustained almost entirely on revenues generated from the inspections and registrations of x-ray equipment and the licensure of radioactive materials. Without the ability to set the fee schedule for these services, VDH would not be able to provide adequate oversight of x-ray machines and radioactive materials in the Commonwealth of Virginia. Additionally, the Board is required to promulgate the fee schedule and in order to comply with such legislative mandate, no viable alternatives exist without the regulations set forth in 12VAC5-490.
