The intent of amending the Regulations Governing Outpatient Health Data Reporting 12VAC5-218 is to better align the chapter with inpatient-level data reporting requirements and to expand outpatient data reporting. Since the initial promulgation of these regulations, the provision of patient care has shifted away from the inpatient setting with a substantial and growing volume being provided in an outpatient setting.

While the inpatient-level data reporting requirements have consistently resulted in timely, comprehensive, and high-quality data collection, the current outpatient-level data collection standards have not achieved the same desired outcomes. The regulatory changes that will be proposed will leverage the knowledge gained over the past decades on the ideal scope and structure of the outpatient-level data system to make it consistent with mature programs in other states and to account for the trend of migration from inpatient to outpatient services. Amending will also allow the language to be updated for consistency of

the definitions within the regulation and allow for the consideration of public comments received. [RIS2] Acronyms and Definitions

The Virginia Department of Health conducted a periodic review of the chapter pursuant to Executive Order 19 and § 2.2-4017 of the Code of Virginia. This periodic review resulted in the recommendation to amend 12VAC5-218 to reflect current outpatient data reporting requirement needs.

The State Board of Health, pursuant to § 32.1-12 of the Code of Virginia, is authorized to "make, adopt, promulgate and enforce such regulations and provide for reasonable variances and exemptions therefrom as may be necessary to carry out the provisions of [Title 32.1] and other laws of the Commonwealth administered by it, the Commissioner or the Department."

Section 32.1-276.2 of the Code of Virginia requires that the State Board of Health administer the health care data reporting initiatives established by Chapter 7.2, Title 32.1 of the Code.

Section 32.1-276.6 of the Code of Virginia requires the State Board of Health to promulgate regulations specifying the format for submission of outpatient data.

The inpatient-level data system has provided vital insights to the Virginia Department of Health, healthcare providers, health plans, and the medical research community for over 25 years. By

standardizing and expanding the outpatient level system, these groups will have access to comprehensive and trustworthy data to drive quality improvements in outpatient data procedures. While the collection of this data is very valuable to the Commonwealth, it does require time and resources on behalf of healthcare providers to submit. The level of effort required of facilities that have traditionally not submitted inpatient or outpatient-level data in the past should be monitored. VDH will also consider the increased cost of reporting and processing more data as part of a comprehensive outpatient-level system.

Substance

In order for 12VAC5-218 to more closely align with 12VAC5-217, VDH is considering the following modifications and additions that pertain to data collection:

- The establishment of new requirements in order to allow VDH to collect more robust outpatient data.
- The establishment of an annual fee for providers who do not submit their data in a timely manner.
- The establishment of a late fee for an outpatient provider that does not submit a complete filing of patient-level data required by 12VAC5-218-20 pursuant to the times established in 12VAC5-218-60.
- The deletion of the last sentence in the definition of "outpatient surgical procedures" in 12VAC5-218-10 due to its reference to a pilot study.
- Any other revisions to the regulations that may be proposed based on public comment or the regulatory advisory panel.

Alternatives to Regulation

There are no viable alternatives for achieving the purpose of the existing regulations. Section 32.1-276.6 of the Code of Virginia requires the Board of Health to promulgate regulations specifying the format for submission of outpatient data. Amending the regulation is the least burdensome and most efficient approach to obtaining the desired outcome of VDH collecting more robust outpatient data and having consistency of definitions within its regulations. During this rulemaking process, the Board will consider all public comment received and will consult stakeholders to discuss any potential less intrusive or less costly alternatives for regulated entities, including small businesses.
