Purpose

The regulatory action is to update the regulation to incorporate by reference the newest available nationally recognized model building codes and standards produced by ICC. The ICC International Fire (IFC) is the major model code. The IFC further references the ICC building, mechanical, plumbing, gas and electrical codes. The ICC codes are known collectively as the "I-Codes."

In conjunction with incorporating the newest available I-Codes into the regulation, the entire regulation will be subject to review and change. This is due to the fact that the I-Codes constitute the majority of the regulation and the various parts of the regulation must be coordinated with the use of the I-Codes which necessitates scrutiny of the entire regulation.

This action is exempt from Article 2 of the Administrative Process Act under § 2.2-4406(13) of the Code of Virginia.

The statutory authority to update the regulation is contained in § 27-97 of the Code of Virginia. The promulgating agency is the Board of Housing and Community Development. State law does require the Board to keep the regulation up to date.

Need

The enabling law for the SFPC requires the Board to keep the regulation up to date. The newest model codes become available every three years, so when they become available, the Board initiates a regulatory action to update the SFPC to include them. The newest I-Codes are the 2009 editions, which became available in early 2009. The current SFPC uses the 2006 editions of the I-Codes.

Substance

The proposed regulation will update all references to the I-Codes from the 2006 to the 2009 editions. In addition, any changes to the I-Codes which were made in the current SFPC have been reviewed to determine whether the 2009 editions of the I-Codes have consistent provisions. Those changes to the I-Codes which were made in the current SFPC and are no longer necessary due to there being consistent provisions in the 2009 I-Codes are deleted in the proposed regulation. The proposed regulation will also contain minor changes to the I-Codes or to the associated administrative provisions of the regulation which have been vetted through the client groups affected by the SFPC and have met no opposition.

Alternatives

As the use of the latest I-Codes to encompass the bulk of the regulation is based on statutory requirements, the agency believes this action to be the least burdensome or intrusive method of meeting the essential purpose of the action.
