On July 22, 2019 the Board of Housing and Community Development, after conducting a periodic review, adopted the legislative updates to Public Participation Guidelines.

A periodic review of the regulation identified legislative changes to Public Participation Guidelines statute that had not been incorporated into the regulation. At their May 13, 2019 meeting, the Board determined the regulation should be amended. The Board adopted the amendments at their July 22, 2019 meeting.

As this change is intended to update the regulation to conform with statute it is expected to be noncontroversial and the fast-track process is appropriate.

This regulatory change is intended to bring the Public Participation Guidelines into conformance with state code and model guidelines development by the Department of Planning and Budget.

This change brings the regulation into conformance with language present in the Code of Virginia. The change clarifies that public commenters may be represented by counsel or other representatives.
