This action establishes a new program, the Day Support Waiver for Individuals with Mental Retardation ("Day Support Waiver") to provide day support and prevocational services for individuals who are waiting to receive services under the Mental Retardation Waiver ("MR Waiver").

The Code of Virginia (1950) as amended, § 32.1-325, grants to the Board of Medical Assistance Services the authority to administer and amend the Plan for Medical Assistance. The Code of Virginia (1950) as amended, § 32.1-324, authorizes the Director of DMAS to administer and amend the Plan for Medical Assistance according to the Board's requirements. The Medicaid authority as

established by § 1902 (a) of the *Social Security Act* [42 U.S.C. 1396a] provides governing authority for payments for services, and § 1915 (c) of the *Social Security Act* provides for home and community based waiver programs such as the Day Support Waiver for Individuals with Mental Retardation.

Purpose

The purpose of this action is to establish a new program, the Day Support Waiver for Individuals with Mental Retardation ("Day Support Waiver"), to provide day support and prevocational services for individuals who are waiting to receive services under the Mental Retardation Waiver ("MR Waiver"). In September 2005, there were approximately 2,900 individuals waiting to receive services under the Mental Retardation Waiver ("MR Waiver"). Individuals in the Day Support Waiver program will receive services until they are no longer eligible for Day Support Waiver services.

Substance

New regulations containing the policy and procedures for the Day Support Waiver were developed in consultation with members of the General Assembly and in collaboration with DMHMRSAS and the MR Waiver Advisory Committee. The regulations are contained in six new sections under 12VAC30-120, Department of Medical Assistance Services, Waivered Services. The six sections are: 12VAC30-120-1500 which contains definitions of Day Support Waiver terms; 12VAC30-120-1510 which contains general coverage and requirements for Day Support Waiver services; 12VAC30-120-1520 which outlines individual eligibility requirements; 12VAC30-120-1530 which defines general requirements for home and community-based participating providers; 12VAC30-120-1540 which defines participation standards for home and community-based waiver services participating providers; and 12VAC30-120-1550 which further defines the covered services and outlines requirements for providers of these services.

This Waiver covers only those individuals who have a diagnosis of mental retardation. Day support services include training, assistance, and specialized supervision in the acquisition, retention, or improvement of self-help, socialization, and adaptive skills, which typically take place outside the home. Day support services shall focus on enabling the individual to attain or maintain his maximum functional level. Prevocational services are those services aimed at preparing an individual for paid or unpaid employment. They do not include activities that are specifically jobtask oriented but focus on concepts such as accepting supervision, attendance, task completion, problem solving and safety. Compensation, if provided, is less than 50% of the minimum wage.

The regulations are necessary to have operational authority for the waiver that is currently operating under emergency regulations. The emergency regulations will expire on June 30, 2006.

The primary advantage of these proposed regulations is that the Day Support Waiver provides an alternative for those individuals on the MR Waiver waiting list who could benefit from day support and prevocational services. By providing services to individuals with mental retardation in the community, the waiver is also intended to help delay or prevent institutional placement. There are no known disadvantages of these regulations to the agency, the public or the Commonwealth.

Projected cost to the state to implement and enforce the proposed regulation, including (a) fund source / fund detail, and (b) a delineation of one-time versus on-going expenditures	The Medicaid funded Day Support Waiver will be offered under a 1915(c) home and community based care waiver that must be a cost-effective alternative to institutionalization. Including medical funding and administrative costs, the waiver is projected to cost \$5,837,400 (\$2,918,700 GF) during FY 2006. The Governor and General Assembly approved these amounts in the 2004 Appropriations Act. The appropriations for the waiver are sufficient to fund 300 individuals. Expenditures are expected to be on-going.

There are 119 day support providers and 55 prevocational providers. With the exception of 38 Community Services Boards that are government operated (approximately 30 of which also provide day support and/or prevocational services), all of the providers would qualify as small businesses.

With the additional available slots, some providers may need to hire additional staff if they choose to increase the number of individuals served through their programs. As the cost for increased staff will vary by individual provider, the state cannot project this cost to providers.

Currently, individuals can pay privately for services but few can afford the cost. Localities are also paying for day support but funding is limited. These regulations were developed by DMAS in concert with the MR Advisory Committee that includes parents of children served by the MR Waiver. Many of the choices made regarding various aspects of this program were based upon input by this Committee.
