The Director of the Department of Medical Assistance Services is amending this regulation to incorporate changes to the state plan text related to the Drug Utilization Review Program in accordance with the requirements of the Support Act (Public Law No. 115-271). These changes ensure that DMAS will remain in compliance with federal regulation to ensure continued federal financial participation. In addition, as a result of the Support Act, DMAS updated its state plan through State Plan Amendment (SPA) #: 19-017 with an effective date of December 31, 2019. This regulatory action is eligible for the fast-track process because none of the changes are expected to be controversial.
