The Department of Motor Vehicles intends to consider amending section 24VAC20-82-2, Overload permit requirements, to remove the subsections E.1. and H. The removal of these sections should not detrimentally affect any citizens of the Commonwealth and would reduce the regulatory burden on motor carrier businesses. The agency does not anticipate that these changes are controversial and, as such, believes that the fast-track rulemaking process found in § 2.2-4012.1 of the Code of Virginia would be applicable to this regulatory action.

This regulatory action was commenced on April 5, 2024. DMV intends to remove subsections E.1 and H from 24VAC20-82-20. Overload permit requirements.

DMV concluded a review of its regulations as part of the ongoing regulatory reduction process mandated by Executive Order 19 and determined that these changes would reduce the regulatory burden on motor carrier businesses while not detrimentally affecting citizens of the Commonwealth.

DMV regulations are promulgated under the general authority of § 46.2-203 of the Code of Virginia which grants DMV statutory authority to promulgate regulations “necessary to carry out the laws administered by the Department.” Section 46.2-1128 of the Code of Virginia authorizes DMV to grant an overload permit to certain vehicles that exceed statutory weight limits and specifically provides that DMV may promulgate regulations governing such permits. Sections 46.2-1139 et seq. of the Code of Virginia authorize DMV to issue permits that allow certain vehicles that exceed statutory weight or size limits to operate on the highway and authorize DMV to promulgate regulations governing such permits.

This regulatory action would remove subsections E.1 and H from 24VAC20-82-20. This regulatory action would also rearrange the remaining numbered sections in subsection E for clarity.

The proposed regulatory action does not present any disadvantages to the public or the Commonwealth. DMV does not have specific data related to the time spent by motor carrier businesses removing expired decals from vehicles, but can infer that the removal of this regulatory requirement will save motor carrier businesses money by eliminating any payroll costs associated with employees removing expired decals from vehicles.
Benefits the regulatory change is designed to produce.	The regulatory action would add additional clarity to the steps required to obtain a permit and save motor carrier companies time and money by removing the requirement that they must remove expired permit decal from vehicles.

This change was proposed to streamline the process and provide additional clarity regarding the pricing of the fee. DMV does not anticipate any additional impact beyond the intended effects mentioned above.
24VAC20-82-20(H)		Regulated parties are required to remove or destroy expired decals.	Regulated parties will not be required to remove or destroy expired decals. The agency has determined that any benefit created by this requirement can be maintained using other methods that do not introduce a regulatory burden on the regulated party. As discussed above, the impact of this regulatory change is that motor carrier companies would save any time or money that is spent removing expired permit decal from vehicles.
