This regulatory action is in compliance with Chapter 615 of the 2015 Acts of Assembly, which transferred administration of T&M Vehicle, Trailer, and Motorcycle Dealer Advertising Practices and Enforcement Regulations (24VAC20-110) from the Department of Motor Vehicles (DMV) to the Motor Vehicle Dealer Board (MVDB). This regulatory action would repeal regulatory Chapter 24VAC20-110 from DMV's administrative regulations.

As part of the regulatory reform efforts DMV has reviewed its regulations and approved repealing the T&M Vehicle, Trailer, and Motorcycle Dealer Advertising Practices and Enforcement Regulations (24VAC20-110) of the *Virginia Administrative Code* for submission through the fast-track regulatory process.

This regulatory action is in compliance with Chapter 615 of the 2015 Acts of Assembly which transferred administration of the T&M Vehicle, Trailer, and Motorcycle Dealer Advertising Practices and Enforcement Regulations from the DMV to the MVDB.

Section 46.2-203 of the *Code of Virginia* provides DMV with specific and general authority to adopt reasonable administrative regulations necessary to carry out the laws administered by the Department and the Commissioner may enforce these regulations and laws through the agencies of the Commonwealth he may designate. Chapter 615 of the 2015 Acts of Assembly transferred administration of the T&M Vehicle, Trailer, and Motorcycle Dealer Advertising Practices and Enforcement Regulations from the DMV to the MVDB. Therefore, the DMV's T&M Vehicle, Trailer, and Motorcycle Dealer Advertising Practices and Enforcement Regulations (24VAC20-110) must be repealed.

The intent of this legislative action is to repeal the regulations in Chapter 24VAC20-110 in the *Virginia Administrative Code*.

Regulatory section 24VAC20-110 will be repealed since the administration of T&M Vehicle, Trailer, and Motorcycle Dealer Advertising Practices and Enforcement Regulations was transferred to the MVDB in 2015.

DMV is not aware of applicable federal requirements associated with the repeal of DMV's regulations. The authority to enforce the T&M Vehicle, Trailer, and Motorcycle Dealer Advertising Practices and Enforcement Regulations was transferred to the MVDB. The DMV regulations are obsolete.
