Chapter 1168 of the 2020 Acts of the General Assembly repealed Chapter 23.4 (54.1-2355 through 54.1-2358) of Title 54.1 of the Code of Virginia. By repealing this Chapter the Department of Professional and Occupational Regulation will no longer have the authority to regulate Natural Gas Automobile Mechanics and Technicians, which makes these regulations obsolete. As the Department has no discretion but to sunset the program, this is being done by an exempt action.
