This action amends 22VAC30-80-20 (Assessment) to address changes to the supportive housing residential option for Auxiliary Grant (AG) eligible individuals as derived from Chapters 657 and 658 of the 2019 Acts of Assembly (original legislation: HB2017 and SB1286). With the revisions, 22VAC30-80-20 will allow individuals receiving AG to select supportive housing (SH) without any requirement that such individuals wait until their first or any subsequent annual reassessment to make a SH selection.

Mandate and Impetus

The 2019 Acts of Assembly, Chapters 657 and 658, enactment clause #2 directed the Commissioner of DARS to promulgate regulations for the provision of supportive housing for individual receiving auxiliary grants within 180 days. Since the regulatory revisions are necessary to conform to changes in Virginia statutory law where no agency discretion is involved, an exempt action will best allow DARS to fulfill enactment clause #2 requirement.
