This action amends three sections in 22VAC30-40 (Protections of Participants in Human Research) to address a legislative change to the listing of covered entities as derived from § 51.5-132 of the Code of Virginia. With the revisions made through Chapter 728 of the 2020 Acts of Assembly (original legislation: HB1148), 22VAC30-40 will specifically identify area agencies on aging (AAAs) as covered entities subject to the department's human research review committee (HRRC).

The 2020 Acts of Assembly, Chapter 728, adds AAAs to listing of entities subject to the department's HRRC. Changes are needed to sections 10 (Definitions), 30 (Applicability), and 50 (Certification process) to account for the explicit inclusion of AAAs in § 51.5-132 of the Code of Virginia.

The Commissioner of the Department approved the amendments to the Protections of Participants in Human Research (22VAC30-40) on September 3, 2020.
