The proposed amendments to 19 VAC 30-160, Standards and Specifications for Safety Lights for Farm Tractors in Excess of 108 Inches in Width, are revised in order to make the regulation consistent with the Society of Automotive Engineers (SAE) Standards J575 and J974, upon which the standards and specifications are based. Minor technical and administrative changes are included. Proposed changes will have no impact on currently approved lighting equipment, as basic approval standards are not being changed. The amendment is expanded to add language consistent with Section 46.2-1005 of the <u>Code of Virginia</u>, adds the definition of farm tractor and highway, and revises wording to be consistent with Society of Engineers standards. Information concerning approval of the lighting equipment has been more fully explained and made more

accessible to the public. Other changes are made in accordance with the Virginia Register Form, Style and Procedure Manual. Individual changes are explained in the Detail of Changes section of this report. There have been no apparent enforcement problems related to this lighting requirement, and the proposed changes will have no impact on enforcement by State Police.

There have been no substantive changes to this proposed amendment since the proposed action was published.

The final action taken by the Department of State Police was completion of the Proposed Regulation stage. The Proposed Regulation was printed in the Virginia Register, Volume 17, Issue 4, on November 6, 2000. No public comments were received. The current action is the Final Regulation stage for this amendment. The title of the regulation is **Standards and Specifications for Safety Lights for Farm Tractors in Excess of 108 Inches in Width.**

Virginia regulation 19 VAC 30-160 was adopted to establish standards and specifications for safety lights for farm tractors in excess of 108 inches in width. The proposed changes to this regulation are intended to:

- 1. Provide the proper referenced sections of the Society of Automotive Engineers (SAE) Standards J575 and J974.
- 2. Correct spelling or other non-substantive errors.
- 3. Clarify the existing regulation.
- 4. Make the existing regulation consistent with the Society of Automotive Engineers (SAE) Standards J575 and J974.

The Office of the Attorney General has certified that the agency has the statutory authority to promulgate the proposed regulation in accordance with § 46.2-1005 of the <u>Code of Virginia</u> and the revisions comport with applicable state and/or federal laws.

Purpose

The statutory responsibility for establishing standards and specifications for safety lights for farm tractors in excess of 108 inches in width required by § 46.2-1102 of the <u>Code of Virginia</u> rests with the Superintendent of the Department of State Police. To fulfill this responsibility, regulation 19 VAC 30-160 was established. This regulation is based upon the Society of Automotive Engineers (SAE) Standards J575 and J974.

Section 46.2-1102 of the <u>Code of Virginia</u> reads as follows:

46.2-1102. Size limitations inapplicable to farm machinery, agricultural § multipurpose drying units, and fire-fighting equipment. -- The vehicle size limitations contained in Articles 14 through 17 (§ 46.2-1101 et seq.) of this chapter shall not apply to any farm machinery or agricultural multipurpose drying unit when such farm machinery or agricultural multipurpose drying unit is temporarily propelled, hauled, transported, or moved on the highway by a farm machinery distributor or dealer, fertilizer distributor, or farmer in the ordinary course of business. Nor shall those limitations apply to fire-fighting equipment of any county, city, town, or fire-fighting company or association. Any farm tractor or agricultural multipurpose drying unit wider than 108 inches, however, which is so propelled, hauled, transported, or moved on the highway shall be equipped with a safety light of a type approved by the Superintendent of State Police. The light shall be plainly visible from the rear of the tractor or agricultural multipurpose drying unit. (Code 1950, § 46-326; 1950, p. 982; 1952, c. 403; 1956, c. 483; 1958, c. 541, § 46.1-332; 1962, c. 197; 1973, c. 183; 1974, c. 361; 1989, c. 727; 1993, c. 151.)

Substance

Only those safety lights required by § 46.2-1102 of the <u>Code of Virginia</u>, and which meet or exceed the standards set forth in Virginia regulation 19 VAC 30-160 are approved for sale and/or use.

The statutory responsibility for establishing standards and specifications for safety lights for farm tractors in excess of 108 inches in width required by § 46.2-1102 of the <u>Code of Virginia</u> rests with the Superintendent of the Department of State Police. To fulfill this responsibility, regulation 19 VAC 30-160 was established. A recent review of this regulation revealed the need to make several changes to the existing regulation to make it consistent with the Society of Automotive Engineers (SAE) Standards J575 and J974 upon which this regulation is based. There are no disadvantages to the public or the Commonwealth of Virginia.

Page 1 - 19 VAC 30-160-30 is reworded by making the section heading consistent with the wording used in the Society of Automotive Engineers (SAE) Standard J974 (Flashing Warning Light for Agricultural Equipment.)

Page 2 - 19 VAC 30-160-40 section heading has been reworded by making the section heading consistent with the wording used in the Society of Automotive Engineers (SAE) Standard J575.

Page 2 - 19 VAC 30-160-40, Section B through Section L is revised by deleting an inaccurately referenced section.

Page 2 - 19 VAC 30-160-40 is revised by addition of Section 3.1 through Section 3.6 in accordance with the SAE J575 Standard.

Page 3 - 19 VAC 30-160-50 is added for consistency with the Society of Automotive Engineers (SAE) Standard J575.

Page 3 - 19 VAC 30-160-50, Section 4.1 through 4.7 is added for consistency with the Society of Automotive Engineers (SAE) Standard J575.

Page 3 - 19 VAC 30-160-60 is renumbered due to previous numbering changes.

Page 3 - 19 VAC 30-160-70 is renumbered due to previous numbering changes.

Page 3 - 19 VAC 30-160-80 is renumbered due to previous numbering changes.

Page 3 - 19 VAC 30-160-80 text is revised by deleting the effective date of this regulation.

Page 3 - the date that this regulation was adopted has been deleted.
