As the result of a comprehensive review of all of its regulations, TAX has identified numerous regulations that have been made obsolete by changes in state or federal law, such as the repeal of the public service corporation exemption effective September 1, 2004. Some of these regulations provided transitional provisions for the one-half percent retail sales and use tax increase effective January 1, 1987 and are deemed to be unnecessary. As these regulations are obsolete, they are being repealed. Repeal of these regulations does not reflect a change in existing departmental policy.

23 VAC 10-210-370. Common carriers of property by motor vehicles. The 1995 Federal Deregulation of the trucking industry and the state repeal of the public service corporation retail sales and use tax exemption as a result of Virginia's 2004 Tax Reform renders this regulation obsolete.

23 VAC 10-210-3020. Public utilities. The state repeal of the public service corporation exemption resulting from the 2004 Tax Reform renders this regulation obsolete.

23 VAC 10-210-5090 through 10-210-5094. Transitional provision. These regulations were adopted in 1987 to implement the state sales and use tax rate increase from 3% to 3.5% and are obsolete.

The Tax Commissioner approved the repeal of these regulations on October 14, 2005.
