Effective July 1, 1995, the Peanut Excise Tax Rate was increased from \$0.10 per 100 pounds to \$0.15 per 100 pounds. (1995 Acts, Chapter 160). This regulatory action will repeal this regulation that is obsolete due to the statutory change.
