As the result of a comprehensive review of all of its regulations, TAX has identified numerous regulations that address statutes that are clear and unambiguous, that are inconsistent with current statutes, or that have been rendered obsolete as a result of current statutes. The Tax Commissioner approved the repeal of these regulations on October 14, 2005.
