This regulation sets forth the rules and procedures VDOT will follow in providing relocation services and payment to property owners displaced by highway improvement projects. It is partially based on the Uniform Relocation Assistance and Real Property Acquisition Act, which is implemented by 49 CFR Part 24. The Federal Highway Administration (FHWA) published a Final Rule outlining revisions to the federal regulation in the *Federal Register* in Volume 70, Number 2, dated January 4, 2005, with a February 3, 2005 effective date. These changes were the result of a multi-year comprehensive revision of the federal regulation, which had not been fully reviewed or updated since its issuance in 1989. These changes are intended to:

- clarify present requirements;
- meet modern needs; and
- improve the service to individuals and businesses affected by federal or federally-assisted projects while at the same time reducing the burdens of government regulations.

The FHWA also issued instructions providing for a one-year transition period to allow state DOTs to update their manuals, regulations, and other pertinent documentation. The Office of the Attorney General

reviewed the changes, and affirmed that this regulatory action is exempt from the operation of Article 2 of the Administrative Process Act because it resulted from changes in federal law or regulation (§ 4006 (A) (4) (c).
