George Mason University repeals 8VAC35-10, 8VAC35-22, and 8VAC35-80. George Mason University amends 8VAC35-31. The repealed regulations govern vehicles on George Mason University's campus and unclaimed personal property on George Mason University's campus. The amended regulation governs the entry upon or use of George Mason University property. These regulations are exempt pursuant to Virginia Code §2.2- 4002(6).

Mandate and Impetus

These actions are the result of a review of all George Mason University regulations. 8VAC35-10, 8VAC35-22, and 8VAC35-80 duplicate existing George Mason University policies and are not necessary. 8VAC35-31 has been revised to bring it into accord with George Mason University's current policies. The Board of Visitors of George Mason University has approved the repeal and revision of these regulations pursuant to the Board's authority under Virginia Code §23.1-1301(A)(1).
