The Virginia Marine Resources Commission (VMRC) proposes to amend Chapter 4VAC20-1270-10 et seq., "Pertaining to Atlantic Menhaden", to establish a quota and license transfer system for the menhaden purse seine bait sector.

Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2. In addition, this is to comply with the requirements of 391(D) of the 2024 Commonwealth of Virginia Budget Bill.

[Impetus] Currently, Chapter 1270 Pertaining to Atlantic Menhaden is written such that only two persons meet the limited entry requirements to hold purse-seine menhaden bait quota and licenses. The eligibility for those licenses cannot be transferred. Quota can only be transferred between license holders. The purpose of these amendments is to allow the transfer of licenses and quota to people or entities that currently don't qualify.
