The Virginia Marine Resources Commission (VMRC) is amending Chapter 4VAC20-390-10 et seq., "Wetlands Mitigation -- Compensation Policy", to comply with the mandate of Chapter 334 of the 2023 Acts of the Virginia General Assembly (HB 1950).

## **Mandate and Impetus**

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2.

[Impetus] The proposed updates, mandated by HB 1950 and § 28.2-1308 of the Virginia Code, will bring the state guidance into conformity with existing federal and state regulations. The revision to the regulation can foster a market-based approach to compensatory mitigation through the establishment of additional wetlands mitigation banks. Additionally, this update would better facilitate meeting the Commonwealth's obligation as a signatory to the Chesapeake Bay Program Agreement to achieve no net loss of wetlands from the Commonwealth's permitting programs.
