The Virginia Marine Resources Commission (VMRC) is amending Chapter 4 VAC 20-720-10 et seq., "Pertaining to Restrictions on Oyster Harvest", to extend the oyster harvest area seasons in both the James River Areas 1, 2, and 3, and Rappahannock River Area 2 for the immediate preservation and protection of the seafood industry under Title 28.2-210 of the Code of Virginia.

The Virginia Marine Resources Commission (VMRC) is amending Chapter 4 VAC 20-720-10 et seq., "Pertaining to Restrictions on Oyster Harvest", to extend the oyster harvest area seasons in both the James River Areas 1, 2, and 3, and Rappahannock River Area 2 for the immediate preservation and protection of the seafood industry under Title 28.2-210 of the Code of Virginia.

VMRC has authority to extend the oyster season or open and close any area at any time to public harvest, outside of the season established by 28.2-506, if the intent is to "to protect or promote the growth of oysters" as is required by 28.2-507.

§ 28.2-210, If, in an emergency, the adoption of a regulation is necessary for the immediate preservation of the public peace, health, safety, and welfare, or the protection of the seafood industry, natural resources or marine organisms, the Commission may promulgate the necessary regulation. The regulation shall be published and filed as prescribed in § 28.2-209. No regulation adopted as an emergency regulation shall remain in effect longer than thirty days unless a public hearing is held as required in § 28.2-211 after being advertised as prescribed in § 28.2-209.

## **Purpose**

Harvest areas and seasons are time sensitive to natural resources of the Commonwealth that have short windows for the industry and public to efficiently use the resource. Both seasonal areas that are purposed

to be amended by emergency would close either at the end of January or the beginning of February which would prevent public notice. Due to seasonal closures of these areas at the end of January and mid-February it does not allow for timely notice to the public for a public hearing. The Virginia Marine Resources Commission (VMRC) is amending Chapter 4 VAC 20-720-10 et seq., "Pertaining to Restrictions on Oyster Harvest", to extend the oyster harvest area seasons in both the James River Areas 1, 2, and 3, and Rappahannock River Area 2 for the immediate preservation and protection of the seafood industry under Title 28.2-210 of the Code of Virginia.

- 14. Rappahannock River Rotation Area 2: December 1, 2022 through <del>January 31</del> <u>February 24</u>, 2023 (hand scrape only).
- 19. James River Areas 1, 2, and 3: October 17, 2022, through February 44 24, 2023 (hand scrape only).

Prior to October 1st of each year, VMRC meets to establish, by regulation, Chapter 4 VAC 20-720-10 et seq., "Pertaining to Restrictions on Oyster Harvest", the areas of public oyster harvest, public oyster harvest seasons and oyster resource conservation measures if they wish these to be different from those which are established by 28.2-506 of The Code of Virginia. VMRC has no requirement to change the oyster season established by code, but may do so, per section 28.2-507 of the Code of Virginia, "in order to protect or promote the growth of oysters". Any changes to the season established in code should take into account this requirement.
