The Virginia Marine Resources Commission (VMRC) is amending Chapter 4 VAC 20-720-10 et seq., "Pertaining to Restrictions on Oyster Harvest", to adjust the public oyster harvest season.

Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2, including marine fisheries regulations.

[Impetus] The Commission meets to establish the areas of public oyster harvest, public oyster harvest seasons and oyster resource conservation measures if they wish these to be different from those which are established by 28.2-506 of The Code of Virginia. The Commission has no requirement to change the oyster season established by code, but may do so, per section 28.2-507 of the Code of Virginia, "in order to protect or promote the growth of oysters".
