The Virginia Marine Resources Commission (VMRC) is amending Chapter 4 VAC 20-270-10 et seq., "Pertaining to Blue Crab Fishery", to adjust the season and bushel limits for the remainder of the 2023 commercial crab pot fishery and to remove discretionary time of year restrictions on fish pots.

Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2, including marine fisheries regulations.

[Impetus] At the June 27, 2023, Commission meeting, the Commission voted unanimously to hold a meeting of the Crab Management Advisory Committee (CMAC) before September 1 to discuss changing fall bushel limits. At their August 3 meeting, CMAC voted unanimously to maintain current bushel limits through October 31, lower bushel limits beginning November 1, 2023, and extend the crab pot season end date from November 30 to December 16, 2023. Section 40, subsection D is also being repealed to remove restrictions on fish pots which were made obsolete by more recent management changes.
