The Virginia Marine Resources Commission (VMRC) is amending Chapter 4VAC20-950-10 et seq., "Pertaining to Black Sea Bass", to open a recreational black sea bass season in February 2024.

## **Mandate and Impetus**

[Impetus] Since 2018, the National Marine Fisheries Service has opened federal waters for a recreational black sea bass fishery in February under the condition that any state participating must pay back their February landings during the regular May through December recreational season. In 2020, ASMFC and MAFMC said they support continuing the February recreational season option for states. On December 13, 2023, ASMFC approved Virginia's proposal for a February 2024 recreational season.
