The Real Estate Board is amending an existing regulation to conform to HB 2229, enacted by the General Assembly during the 2021 Special Session I. The legislation, effective July 1, 2021, enumerates conditions for real estate licensees handling rental agreements in the event that a dwelling unit used as a single-family residence is foreclosed upon and there is a tenant in such dwelling unit on the date of the foreclosure sale.

Regulation 18 VAC 130-20-180, concerning the maintenance and management of escrow accounts, contains language that must be updated to reflect the statutory changes to § 54.1-2108.1 of the Code of Virginia. This action conforms the regulation to the law and is exempt from the Administrative Process Act because there is no agency discretion pursuant to § 2.2-4006(A)(4)(a) of the Code of Virginia.

Mandate and Impetus

The General Assembly enacted Chapter 426 during its 2021 Special Session I, thus mandating the Real Estate Board update the regulation derived from the amended statute (§ 54.1-2108.1) to conform to the changes.
