There is not a continued need for this regulation. The agency is currently unaware of any complaints or comments concerning the regulation. The regulation overlaps with § 22.1-258 of the Code of Virginia as well as 8VAC20-110. The extent of any overlap with federal law is unknown. The regulatory chapter was last amended in 2021. The agency's decision is not expected to have any economic impact on small business.
