This regulatory action will repeal sections of the Declaration of Estimated Income Tax by Individuals Regulation, 23VAC10-112-40 and 23VAC10-112-41, that provide no additional guidance to clear and unambiguous statutes. The repeal of these sections does not reflect a change in existing tax policy and will have no impact on the administration of the tax.

The Tax Commissioner approved the amendment of the Declaration of Estimated Income Tax by Individuals Regulation by repealing 23VAC10-112-40 and 23VAC10-112-41 on May 2, 2016.

Code of Virginia § 58.1-203 provides that the “Tax Commissioner shall have the power to issue regulations relating to the interpretation and enforcement of the laws of this Commonwealth governing taxes administered by the Department.” The authority for the current regulatory action is discretionary.

This action will repeal two sections of the Declaration of Estimated Income Tax by Individuals Regulation that provide no additional guidance to clear and unambiguous statutes. Repealing these sections does not reflect any change in existing tax policy and will have no impact on the administration of tax.

23VAC10-112-40 sets forth the addition to tax applicable in the case of any underpayment of estimated tax by an individual. 23VAC10-112-41 sets forth the amount of the underpayment for the purposes of calculating the addition to tax. Because these sections merely restate Va. Code § 58.1-492(A) and provide no additional guidance, their repeal is not expected to be controversial.

This regulatory action will ease voluntary taxpayer compliance and the Department's administration of the state tax laws by eliminating unnecessary regulation sections. As these regulation sections are unnecessary, their repeal will result in no disadvantage to the public or the Commonwealth.
