Subject:

Disposal of Used Cooking Oils

Objective:

To ensure food establishments are properly disposing of used cooking oil

in the Commonwealth.

Authority:

Code of Virginia § 62.1-44.34:8 Definition of oil

Code of Virginia § 62.1-44.34:18 Discharge of oil prohibited

Virginia Administrative Code § 12 VAC 5-421-2580 Other liquid wastes

and rainwater.

Background:

The definition of oil in the *Code of Virginia* (§ 62.1-44.34:8) includes used cooking oil. The discharge of any oils onto the ground's surface, into the waters of the Commonwealth, or into storm sewer is prohibited by § 62.1-44.34:18 of the *Code of Virginia*. The *Food Regulations* in §12 VAC 5-421-2580, requires all nonsewage liquids to be disposed of in accordance with law. Improper disposal of oil can contaminate water and create

public health nuisances.

Required Actions:

VDH environmental health specialists, during inspections of food establishments, will determine if the food establishments are properly

disposing of cooking oil.

Responsibility:

District environmental health managers are responsible for ensuring all district food staff are aware of this interpretation and implement it as part of their food establishment inspections. VDH environmental health specialists shall note a violation to §12 VAC 5-421-2580 if they observe the improper disposal of used cooking oil that results in the oil being discharged onto the ground, into the water, or into storm sewers. Also, they will notify the regional office of the Department of Environmental Quality of their observation. Alternatively, if the Department of Environmental Quality receives a complaint involving a restaurant discharge of cooking oil and DEO requests assistance, the VDH

environmental health inspectors will perform an initial investigation of the

complaint.
