The rules shall include but not be limited to provisions for advertising standards to assure full and fair disclosure; provisions for operating procedures; and other rules as are necessary and proper to accomplish the purposes of Chapter 4.2 of Title 55 of the *Code of Virginia*.

The regulation meets the criteria set forth in Executive Order 14 (2010). The regulation governs the exercise of powers granted to and the performance of duties imposed upon the Board by the Horizontal Property Act (§ 55-79.1 et seq. of the *Code of Virginia*) and by the Condominium Act (§ 55-79.39 et seq. of the *Code of Virginia*). The regulation is currently undergoing a general review to ensure that the regulation: complements the current Condominium Act; provides minimal burdens on regulants while still protecting the public; and reflects current procedures and policies of the Department of Professional and Occupational Regulation.

Code of Virginia § 55-79.98 mandates the Common Interest Community Board to promulgate regulations. The continued need for the regulation is established in statute. Repeal of the regulation would remove the current public protections provided by the regulation.

No comments or complaints were received during the public comment period. The regulation is clearly written, easily understandable, and does not overlap, duplicate, or contravene federal or state law or regulation.

Through emergency and final regulations, which became effective on July 9, 2009, the regulations were transferred from the Real Estate Board to the Common Interest Community Board. The most recent action taken was through the fast-track process to promulgate regulations governing the return of bonds and letters of credit as authorized by § 55-79.84:1 of the *Code of Virginia*. This action became effective April 1, 2011. The regulation is currently undergoing a general review.

At its December 1, 2011 meeting, the Board discussed the regulation and, for the reasons stated in this section, determined that the regulation should not be amended or repealed, but should be retained in its current form.
