Sections 3.2-4601 and 3.2-4605 of the Code of Virginia require the Board of Agriculture and Consumer Services to adopt regulations to carry out the purposes of Chapter 46 of Title 3.2, which became effective October 1, 2008. The Board may adopt rules and regulations, after consultation with the Board of Directors of the Virginia State Horticultural Society or the Virginia Apple Growers Association, that prescribe temperature and oxygen level and duration of that level in storage facilities, minimum and maximum exposure of fruit to those conditions, and grade and condition standards applicable to CA apples.

## Alternatives

Please describe all viable alternatives for achieving the purpose of the existing regulation that have been considered as part of the periodic review process. Include an explanation of why such alternatives were rejected and why this regulation is the least burdensome alternative available for achieving the purpose of the regulation.

The agency considered repealing the regulation. However, the regulation is needed to clarify certain provisions of the Code of Virginia pertaining to controlled atmosphere storage of apples.

The agency believes the present version is the least burdensome and least intrusive alternative. For these reasons, the Agency rejected consideration to repeal the regulation.

No comments or complaints were received during the public comment period. The regulation does not duplicate any state or federal laws or regulations. The regulation is not overly complex. The agency has determined that no changes have occurred in the area affected by this regulation since the last periodic review that would make it necessary to amend or repeal the regulation. The agency believes the current version of the regulation is the least burdensome and least intrusive alternative for the apple industry and small businesses.
