Section 3.2-109 of the Code of Virginia (Code) establishes the Board of Agriculture and Consumer Services (Board) as a policy board with the authority to adopt regulations in accordance with the provisions of Title 3.2 of the Code.

Section 3.2-702 of the Code authorizes the agency to conduct surveys for plant pests.

Section 3.2-703 of the Code authorizes the Board to quarantine the Commonwealth or any portion thereof when it determines such action is necessary to prevent or retard the spread of a pest into, within, or from the Commonwealth.

Section 3.2-704 of the Code authorizes the Board to prohibit the importation of any regulated article from any locality of other states, territories, or countries into the Commonwealth when it has good reason to believe in the existence of infested regulated articles in localities in other states, territories, or countries, or that conditions exist that, in the judgement of the Board, render the importation of such regulated articles from such localities a menace to the health of the Commonwealth.

The agency has determined that no viable alternatives exist to achieve the purpose of 2 VAC 5-440, *Rules and Regulations for Enforcement of the Virginia Pest Law – Cotton Boll Weevil Quarantine.*

The purpose of this regulation is to ensure that the cotton boll weevil does not re-infest Virginia. The cotton boll weevil is a plant pest that feeds on the buds of the cotton plant, making it impossible for the plant to produce cotton. The agency believes the regulation is the least burdensome mechanism available to prevent the re-infestation of the cotton boll weevil. The regulation requires an annual cotton boll weevil survey to ensure the early detection of and rapid response to any cotton boll weevil infestations. Early detection and rapid response are important to the successful eradication of an infestation. No cotton boll weevils have been detected in Virginia since 1997, and the annual survey confirms that Virginia is cotton boll weevil-free, thereby enhancing the export of Virginia's cotton. The regulation requires that Virginia's cotton farmers provide the funding necessary to conduct the annual cotton boll weevil survey. The regulation also requires the inspection of articles capable of transporting the cotton boll weevil prior to such articles entering Virginia to ensure the articles are cotton boll weevil-free.

The agency did not receive any comments during the public comment period following the publication of the Notice of Periodic Review on April 27, 2020. An informal advisory group was not formed for the purpose of assisting in the periodic review.

Effectiveness

The regulation assists in the prevention of the re-infestation of the cotton boll weevil in Virginia, thereby protecting the public's health, safety, and welfare. The eradication and exclusion of the cotton boll weevil enhances the quality of the environment by reducing the need for pesticide applications on cotton, which would otherwise be applied to combat the cotton boll weevil. Reduced pesticide applications will also result in decreased production costs for Virginia's cotton growers.

The regulation is clearly written and easily understood.

Decision

The agency has determined that this regulation continues to be necessary in order to prevent the reintroduction of the cotton boll weevil into Virginia and ensure the continued export of Virginia cotton. Virginia cotton growers, many of whom are small business owners, planted approximately 100,700 acres of cotton in 2019. A cotton boll weevil infestation would have a significant negative economic impact on these small business owners. Virginia cotton growers are assessed a per-acre fee to cover the cost of the cotton boll weevil survey. The fee is determined each year by the Commissioner of Agriculture and Consumer Services in consultation with the Board of Directors of the Virginia Boll Weevil Eradication Foundation, Inc. All voting members of this board are Virginia cotton growers.

The agency has not received any complaints or comments concerning the regulation. This regulation does not overlap, duplicate, or conflict with federal or state law or regulations. The regulation was most recently reviewed nine years ago and there have been no changes in technology, economic conditions, or other factors that require the amendment of the regulation.
