This regulation is promulgated by the State Board of Local and Regional Jails, in accordance with §53.1-5 of the Code of Virginia. The regulation is necessary to interpret the law for the protection for the health,

safety, and welfare of facility staff, defendants, and inmates in local, regional, and community correctional facilities.

Effectiveness

6 VAC15-20, Regulations Governing Certification and Inspection, meets the criteria set out in Executive Order 14 (as amended, July 16, 2018) in that it is necessary for the protection of the health, safety, and welfare of staff, defendants, and inmates within local, regional, and community correctional facilities. This regulation has proven effective in meeting this need and is deemed to be easily understandable. Due to changes in the Code of Virginia, technical and clarifying amendments are necessary.

Decision

Amend the regulation:

6 VAC15-20 requires amendments to reflect changes in the name of the Board and other technical and clarification amendments to reflect similar changes made to the Code of Virginia in recent years.

6 VAC15-20, Regulations Governing Certification and Inspection, is necessary for the protection of the health, safety, and welfare of staff, defendants, and inmates within local, regional, and community correctional facilities operating within the Commonwealth of Virginia. There have been no complaints or comments received from the public concerning the regulation. The regulation is not deemed to be overly complex nor does it overlap, duplicate, or conflict with Federal or State law or regulation. Technology, economic conditions, or other factors have not significantly changed in the area affected by the regulations since it was last updated. The regulation was last reviewed in 2015 and last updated 2011. Small businesses do not operate the facilities which are covered by the Code of Virginia and subject to this regulation, as they are all public facilities; therefore, the regulation has no impact on small businesses.
