This regulation, which is required by the Code, establishes official standards and tolerances and inspection guidelines that ensure growers receive quality seed potatoes intended for the production of commercial potatoes. The regulation is effective and being administered in the most efficient and least burdensome manner.

The agency has determined that this regulation continues to be necessary and should remain in effect without change. The agency has not received any complaints or comments regarding the regulation.
