- d. § 32.1-229.2, which states that the fee schedule for inspections of x-ray machines by Department personnel shall include all reasonable costs of such inspections.

Alternatives to Regulation

The Virginia Radiation Protection Regulations: Fee Schedule, 12VAC5-490, remains critical to protecting the public from unnecessary radiation exposure caused by a wide spectrum of applications used in the healing arts, research, educational institutions, and industry. ORH operations are sustained almost entirely on revenues generated from the inspections and registrations of x-ray equipment and the licensure of radioactive materials. Without the ability to set the fee schedule for these services, VDH would not be able to provide adequate oversight of x-ray machines and radioactive materials in the Commonwealth of Virginia. Additionally, the Board of Health is required to promulgate the fee schedule and in order to comply with such legislative mandate, no viable alternatives exist without the regulations set forth in 12VAC5-490.

VDH received no public comments following the publication of the Notice of Periodic Review.

VDH is recommending that 12VAC5-490 be amended to reflect increases in the cost of business operations required to perform inspections and ensure protection of the public from unnecessary radiation exposure. The fee schedule included in 12VAC5-490 was last amended February 7, 2019.

VDH has considered the continued need for 12VAC5-490 and determined that the established fee schedule is still needed in order to sustain operations of ORH, which is almost entirely dependent on revenues from inspections, registrations, and licenses. No public comments were received via the Townhall website, e-mail, or mail. The fee schedule contained within 12VAC5-490 does not overlap, duplicate, or conflict with other federal or state laws or regulations. The fee schedule contained within 12VAC5-490 was last amended February 7, 2019. Since then, inflation and the cost of operations associated with inspections, registrations, and licensing of x-ray equipment and radioactive materials has increased. VDH will take into consideration the effect that a fee increase will have on small businesses, and will make every effort to amend the fee schedule in a manner that covers the costs needed for effective operations of ORH.
