The regulation establishes guidelines for the maintenance of pounds and enclosures. For the purpose of this report, although they are somewhat different, both pounds and enclosures will be referred to simply as "pounds." The regulation also establishes minimal standards of animal husbandry to be practiced in pounds. [Animal husbandry, as applied to pounds, includes cleaning the pound, waste disposal, the safety of animals, the housing of animals, ventilation of the pound, food and water, euthanasia (the humane killing of an animal), and disease control.]

Section 3.1-796.96 of the Code of Virginia (1950), as amended, requires the governing body of each county or city to maintain or cause to be maintain a pound. The law further states that the governing body shall require the pound be operated in accordance with regulations issued by the Board of Agriculture and Consumer Services.

The Department published its notice in The Virginia Register of Regulations on September 11, 2000, advertising the opportunity to comment on this regulation pursuant to Executive Order Twenty-five (98). An informal advisory group was not formed for the purpose of assisting in this periodic review.

The Department received no public comment on this regulation review during the comment period.

The specific and measurable goals of the regulation are:

- 1. To protect the health and welfare of animals in Virginia with the least possible cost and intrusiveness by (a) establishing minimum housing and care standards for the animals maintained in the pounds and (b) when necessary, establishing procedures for the euthanasia of animals.
- 2. To prevent or minimize the introduction of contagious and infectious diseases into animal populations in the Commonwealth by (a) establishing minimum disease control standards that pounds must meet and (b) establish procedures for disposal of dead animals.

The effectiveness of the regulation in achieving these goals is reflected, in part, by the current standard of care provided in the animal pounds.

The regulation is clearly written and easily understandable by the individuals and entities affected.

The considered alternative to this regulation is to eliminate the regulation thereby removing the minimum standards of care, procedures for euthanasia, and procedures for disposal of dead animals. The agency rejects this alternative because, without these minimum standards and procedures, animals in Virginia's pounds may receive a much lower standard of care. Furthermore, disease in companion animal populations may increase.
