The Board of Health is authorized to promulgate these regulations pursuant to Section 32.1-12 of the *Code of Virginia*. *Code* Section 32.1-12 authorizes the Board to make, adopt, promulgate, and enforce such regulations as necessary to carry out the provisions of Title 32.1 and other laws of the Commonwealth administered by the Commissioner of the Department. *Code* Sections 32.1-122.5, 32.1-122.5:1, 32.1-122.6, and 32.1-122.6:01 authorize the Board of Health to award annual medical scholarships for students enrolled full-time at a participating medical school or a graduate of such school. The Office of the Attorney General has certified that the Board of Health has proper authority to promulgate this regulation.

Effectiveness

Please indicate whether the regulation meets the criteria set out in Executive Order 36, e.g., is necessary for the protection of public health, safety, and welfare, and is clearly written and easily understandable.

This regulation is clearly written and is easily understandable. It provides medical scholarships to students in medical school. For every year of a medical scholarship received, the medical student is required to provide a year of primary care service (family medicine, general internal medicine, pediatric medicine, or obstetrics/gynecology) in a Virginia medically underserved area upon completion of residency. Two hundred and fourteen (214) medical students were nominated by participating medical schools into this scholarship award program. Scholarship recipients could have one (minimum) to five (maximum) years of service obligation in the Commonwealth of Virginia. Currently, 11 recipients are still in a residency program and will owe primary care service to the Commonwealth. Also, 24 recipients are still serving in Virginia. Scholarship recipients are increasing access to quality primary care in Virginia's medically underserved area.
