Section 3.2-6002 of the Code of Virginia provides the authority for this regulation and states that the "Board may adopt regulations as may be necessary" to prevent the spread and eradicate contagious and infectious livestock and poultry diseases.

Include an explanation of why such alternatives were rejected and why this regulation is the least burdensome alternative available for achieving the purpose of the regulation.

There are no viable alternatives for achieving the purpose of the existing regulation. The alternative that was considered is to eliminate the regulation and not require any registration or record keeping by poultry dealers. This alternative would place the Virginia poultry industry in the position of being exposed to devastating diseases resulting from the lack of oversight and control of those persons dealing in poultry. Consequently, the existing regulation appears to be the least burdensome alternative to make certain that records are maintained by poultry dealers so that any poultry which become infected can be traced to their source and action initiated to control and eradicate the disease agent.

The Department published its notice in The Virginia Register of Regulations on December 8, 2008, advertising the opportunity to comment on this regulation pursuant to Executive Order 36. The Department did not receive any public comments concerning this regulation. An informal advisory group was not formed for the purpose of assisting with this periodic review.

This regulation does meet the criteria set out in Executive Order 36, in that:

- 1. It protects public health, safety and welfare with the least possible intrusion in the lives of citizens;
- 2. It is based on the best reasonably available scientific, economic and other information;
- 3. It is designed to achieve its intended objective in the most efficient, cost-effective manner;
- 4. It is clearly written and easily understandable by the individuals and entities affected; and,

Exposure of the poultry industry to such catastrophic diseases could result in the collapse of the entire industry and the loss of employment for thousands of individuals.
