Section 3.2-6002 of the Code of Virginia provides the predominant authority for this regulation and states that the "Board may adopt regulations as may be necessary" to prevent the spread and eradicate contagious and infectious livestock and poultry diseases. Additional authority is provided by section 3.2-6001, which states "It shall also be the duty of the Commissioner, the Board, and the State Veterinarian . . in establishing interstate quarantine lines and regulations so as to best protect the livestock and poultry of the Commonwealth against all contagious and infectious diseases".

Alternatives

Please describe all viable alternatives for achieving the purpose of the existing regulation that have been considered as part of the periodic review process. Include an explanation of why such alternatives were rejected and why this regulation is the least burdensome alternative available for achieving the purpose of the regulation.

There are no viable alternatives for achieving the purpose of the existing regulation. The alternative that was considered is to eliminate the regulation and not require poultry companies to submit samples of poultry tissues for analysis or to provide an inventory of their flocks when requested by the State

Veterinarian. The agency rejects this alternative, because the absence of this information would not afford an opportunity for early detection of an infectious or contagious poultry disease, thus allowing disease to spread to healthy flocks. The lack of such a detection system could be devastating to the industry and to the effective control of poultry disease outbreaks.

The Department published its notice in The Virginia Register of Regulations on December 8, 2008, advertising the opportunity to comment on this regulation pursuant to Executive Order 36. The Department did not receive any public comments concerning this regulation. An informal advisory group was not formed for the purpose of assisting with this periodic review.

Effectiveness

This regulation does meet the criteria set out in Executive Order 36, in that:

- 1. It protects public health, safety and welfare with the least possible intrusion in the lives of citizens;
- 2. It is based on the best reasonably available scientific, economic and other information;
- 3. It is designed to achieve its intended objective in the most efficient, cost-effective manner;
- 4. It is clearly written and easily understandable by the individuals and entities affected; and,
- It has been developed in accordance with laws relating to the impact of regulations on small businesses.

This regulation provides a disease surveillance system by requiring submission of poultry specimens for diagnostic testing for avian influenza and other infectious and contagious diseases, and by requiring owners to provide an inventory of their poultry flocks when requested by the State Veterinarian.

Food safety is critical to the health, safety and welfare of all citizens of the Commonwealth. Concerns regarding salmonellosis associated with eggs, for example, have received national public attention. In addition, poultry is an inexpensive form of protein, the low price largely based on a plentiful supply of birds. Other infectious and contagious diseases of poultry, some of which may also be infective to humans, can seriously and negatively impact the numbers of poultry available for food due to death losses and decreased reproduction, with a resultant diminished supply of product and increased cost to consumers. Consequently, the regulations providing for early detection of such diseases are crucial for public protection, preventing poultry shortages, and minimizing economic losses.
