**APPROVAL OF MINUTES**

Mr. Kerr called the meeting to order. He asked for a motion to accept the minutes from the previous meeting. Mr. Watters moved to accept the minutes. Mr. Sugumele seconded the motion. The minutes were approved unanimously.

**BOARD COMMENTS**

Mr. Sugumele asked for an update on any changes in the school milk supply. The carton packaging situation that resulted from the closure of two paper plants will be an ongoing issue nationwide, and it may impact Virginia school districts sporadically. Mr. Wilkes stated that processors had notified him occasionally that supply might be tight, but a lack of cartons had not prevented processors from delivering milk to districts. Dr. Jones mentioned that several school districts, including Pittsylvania County schools, had transitioned to dispensers. She believed that this was a positive move for her district and students, but it likely would not have happened if local dairy farmers had not advocated for the dispensers last summer. He also believed procurement changes would help with supply during the upcoming school year and he intended to provide districts with current production costs over the summer to assist them.

A clarification and review of the electronic meeting policy was also provided at the request of Mr. Watters. The last meeting was the first one held under the agency's new policy, and while there were some technical challenges, it did not pose significant challenges to administer.

**ADMINISTRATOR'S REPORT**

Mr. Wilkes reviewed recent staffing challenges facing the Milk Commission. Two dairy auditor positions were advertised in November through early December but remain unfilled. The positions were readvertised beginning on February 14.

## **NEW BUSINESS**

Mr. Wilkes presented a review of fluid milk sales in 2023. Compared to the previous year, sales had dropped by two percent. He could not point to a single factor that explained the decline but believed that return to office had hampered consumption and baking. Fluid milk experienced some growth during the COVID pandemic isolation period, so it was expected that sales would return to pre-pandemic trends eventually.

Because of the sales decline, the base-to-sales ratio exceeded the regulatory threshold of 108%. The ratio has gradually approached the limit over the last couple of years. At a minimum, a two percent reduction in milk base would be required by regulation. Mr. Wilkes asked for the board's opinion regarding the approval of a larger reduction in base. Mr. Watters stated that it would be wise to further the reduction to five percent, as it improves the chances that cuts will not be required in consecutive years and therefore improves stability. Dr. Jones agreed with the thought, but believed a slightly larger cut may be needed at six percent. Mr. Kerr offered that as a producer that owned milk base, any reduction is not ideal, but he understood the need for it and requested that the minimum amount necessary that would decrease the odds of future cuts be considered.

## **MOTION:**

Mr. Watters made a motion to reduce milk base by five percent, effective March 1, 2024. Dr. Jones seconded the motion.

## **ADJOURNMENT**

The Board adjourned at approximately 3:10 p.m.
