Minute No. 2 – Virginia Water Protection Individual Permit No. 19-0170, Potomac Yard Metrorail Station; City of Alexandria

DEQ staff made a presentation for the issuance of the Virginia Water Protection (VWP) Individual Permit for the Potomac Yard Metrorail Station project (VWP Permit No. 19-0170). The project consists of constructing the Potomac Yard Metrorail Station with an associated entrance pavilion, entrance points, stormwater management facilities, construction staging areas, and 3,750 linear feet of new or re-aligned track. The permit authorizes the total impact of 3.57 acres of surface waters, consisting of 1.56 acres of permanent impacts and 2.01 acres of temporary impacts.

Staff briefed the Board on the proposed permitting action and provided a summary of the most pertinent areas of concern received during the public hearing and public comment period and staff responses to comments.

Following comments of the individuals noted above, staff responded to several questions from the Board and then made the following recommendation:

Based on the (i) Board book material, (ii) public comments made available to the Board and any explanation of comments previously received during the public comment period made at the Board meeting, (iii) public comments made at the Board meeting, (iv) staff presentation, (v) Board discussions, and (vi) agency files on the draft permit:

1. Find that:

- a. The permit has been prepared in conformance with all applicable statutes, regulations, and agency practices;
- b. The proposed activity is consistent with the provisions of the Clean Water Act and State Water Control Law and will protect instream beneficial uses;
- c. The proposed permit addresses avoidance and minimization of surface water impacts to the maximum extent practicable;
- d. The effect of the impact, together with other existing or proposed impacts to surface waters, will not cause or contribute to significant impairment of state waters or fish and wildlife resources;
- e. The proposed permit conditions are sufficient to achieve no net loss of wetland acreage and function through compensatory mitigation;
- f. This permit is designed to prevent unpermitted impacts.
- 2. Approve the permit and conditions as presented in the Board Memo.
- 3. Authorize the Director to issue the permit as approved by the Board.

After hearing the staff recommendation, a motion was made and seconded to approve staff recommendations and direct staff to provide a report on the project six months after start of construction.

Board Decision

The Board, based on the Board book material and presentation at the meeting, voted 6-0 in favor of staff's recommendation.

MINUTE NO. 8 - Water Permitting Division Director's Report

Ms. Melanie D. Davenport reported to the Board on a regulatory action for the certification of nonpoint source nutrient credits and provided an updated on the Mountain Valley Pipeline project.

Regarding the regulatory action, Ms. Davenport reviewed the legislative history, reviewed the regulatory development background and detailed the procedures addressed in the regulation; and, informed the Board that consideration of the final regulation is an agenda item for the December 2019 meeting.

Regarding the Mountain Valley Pipeline project, Ms. Davenport reviewed the results of the Four Corners Farm inspection, the Bradshaw Road investigation and the Green Hollow Road investigation. Ms. Davenport also reported on significant events during the reporting period; e.g., issuance of a stop work instruction and the recording of elevated turbidity readings in the Roanoke River in July. In addition, Ms. Davenport reported on compliance monitoring, common areas of concern observed by the inspectors, complaint statistics and where to final information on complaint investigation findings.
