37	Subcommittee flagged language including the use of the term "matched" and that the
38	examiner indicated that he conducted a visual and not microscopic comparison of the hairs.
39	The Subcommittee determined that notification was appropriate.
40	 A83-00050 was a case where the Review Team indicated notification was required. The
41	Subcommittee felt that the scientist was testifying accurately, but the questions asked by
42	the attorneys were problematic. The Subcommittee agreed that notification was
42 43	appropriate.
