CALL TO ORDER: A meeting of a quorum of the Board of Pharmacy ("Board") was called to order at 9:02AM for the purpose of two possible summary suspension presentations.

PURPOSE:
CASE NO. 234884 Mandy Wilson, Assistant Attorney General, presented a summary of the evidence in this case. Ms. Wilson was assisted by Rebecca Ribley, Adjudication Specialist.

DECISION: Upon a motion by Dr. Dowdy and duly seconded by Dr. Yuan, the Board unanimously voted (7-0) that with the evidence presented, Dillon Breeding poses a substantial danger to the public; and therefore, the Board voted to summarily suspend Mr. Breeding's pharmacist license.

PURPOSE:
CASE NO. 233563

Sean Murphy, Sr. Assistant Attorney General, presented a summary of the evidence in this case. Mr. Murphy was assisted by Jess Weber, Adjudication Specialist.

DECISION:

Upon a motion by Dr. St. Clair and duly seconded by Mr. Kocot, the Board unanimously voted (7-0) that with the evidence presented, Sara Donnell poses a substantial danger to the public; and therefore, the Board voted to summarily suspend Ms. Donnell's pharmacy technician trainee registration and offer a pre-hearing consent order in lieu of a formal hearing.

Board member Dowdy departed the meeting immediately following the decision.
