5. Reports/Announcements:

a. DOAV Report

Randall Burdette DOAV

Mr. Burdette updated the board and attendees on aviation issues and activities across the Commonwealth. The presentation topics included SCAAP; Virginia Volunteer Pilots Group; legislation to be submitted to the 2012 General Assembly, including consistency in FOIA protection, aircraft license to aircraft registration term change, private use airport liability, tower approval, land use protection for airports, and lease approval extending to commissions and authorities; and upcoming events. He mentioned that Airport Support Network members are still needed.

As part of the DOAV report, presentations were provided on the Virginia Airport System Economic Impact Study, Aviation and Aerospace Workforce Analysis and Strategy Development, Aviation Competitive Analysis, and Virginia Resources Authority.

Mr. De'Alema reported that on August 10th, 2011 VRA successf	fully sold \$33.15 million in Virginia
Airports Revolving Fund (VARF) bonds to refund the existing S	eries 2001 A & B VARE bonds All debt

Airports Revolving Fund (VARF) bonds to refund the existing Series 2001A & B VARF bonds. All debt service savings, after costs of issuance, were passed on to the local borrowers in the form of reduced interest rates on local loans. Interest rates on the local loans were reduced by 1.25 percent as a result of the refund savings on the bonds. Mr. De'Alema provided examples of savings for Capital Region Airport Commission (CRAC), Dinwiddie Airport & Industrial Authority, and Norfolk Airport Authority. b. FAA Report

Terry J. Page FAA WADO

Mr. Page reported that a continuing resolution extended AIP authority through September 16, 2011 and FAA must obligate all available funds by September 16. His office's priorities upon returning are to process pay requests for open grant, accelerate programming for 2011 projects and project decisions, and planning for a potential final AIP extension beyond September 16.

Mr. Page shared that the five-year needs for FAA's Eastern Region is \$800 million per year. The available resources for FY2011, assuming a full year of funding is approximately \$440 million, resulting in un-met needs of \$360 million per year. Programming is further impacted by significant runway safety area projects still to be funded, increased fuel and construction costs, and uncertainty regarding future AIP levels. FAA must be very selective with its discretionary funds, focusing on safety, security, rehabilitation, and capacity. He reminded sponsors to keep open grants active and on-budget; practice good capital planning; take ownership of their AIP programs; coordinate with FAA early on project scopes, property appraisals, environmental reviews, and the like; and be prepared to take bids early in the spring.

At the time of his report, FAA WADO has processed \$23 million in executed grants and has another approximate \$30 million of grants in its pipeline. Mr. Page will provide a detailed report of exact 2011 program at next VAB meeting.

Mr. Page discussed two other issues. He has just received approval to fill the vacant WAS ADO environmental specialist position. He also alerted sponsors to a new condition included in all FAA grants that prohibits residential thru-the-fence access to airports.

The board approved the endorsement requested by Dinwiddie County for the Virginia Airport Loan Program project for the Dinwiddie County Airport for the Loan Consolidation, Box Hangar (Design), Apron/Taxi Rehabilitation (Construction), and Hangar Door Replacement in the amount of \$422,124.00. Mr. Mazza abstained from voting on this request as he rents this hangar.

The board was notified that Mr. Burdette authorized an increase to the Tazewell County Airport VRA loan request from \$270,000.00 to \$295,000.00. The reason for change was that the sponsor did not consider bond counsel fees in its application request. The increase was approved by the board.

The board approved a 60-day extension requested by Hanover County Airport for the tentative allocation received May 19, 2011 for the Obstruction Removal - Utilities Bridge Loan project.
