Ms. Cox made a motion that the Board establish a strategic planning committee to focus on ways airports can be integrated with state and local economic development activities with the committee consisting of three VAB members, seven representatives from the VAOC covering the regions, DOAV staff as well as staff from the Virginia Economic Development Partnership, seconded by Mr. Kennedy. Region 1: Mr. Kennedy noted the September 18 event in Wise County and encouraged the Board and airports in that region to participate. He stated that Mountain Empire Community College is currently in negotiations with Embry Riddle to offer an unmanned systems Bachelor's of Science degree program. He also noted UAS opportunities with Embry Riddle and medical sample deliveries in that region.

Region 5: Mr. Mazza thanked staff for the ideas to prevent the loss of federal funding and to provide assistance to the airports.

Region 6: Ms. Dominguez thanked all involved in planning the conference this year and the DOAV staff. She also thanked staff for the creative ways to serve the airports around the Commonwealth. She also appreciated the motion by Ms. Cox for the establishment of the strategic planning group to develop more economic opportunities in the Commonwealth

Region 7: Ms. McLeskey echoed Mr. Mazza's comments. She mentioned Mr. Mazza's appearance in a movie filmed in Suffolk. She acknowledged the success of the 6th annual Women Can Fly event, flying 144 passengers, using 12 aircraft and one helicopter. She thanked staff for the innovative thinking for the rural airport runway program. She also thanked the conference planning committee.

Director: Mr. Flynn added that the February meeting will be hosted at Manassas, with three of the four meetings being held outside of Richmond in 2019.

Chairman: Mr. Hardwick echoed Mr. Mazza's previous comments about the Virginia Aviation Board being the best Board in Virginia, which is supported by the DOAV staff and the tremendous aviation community in Virginia. He added that the conference reflects that aviation in the Commonwealth continues to be the best in the country.
