For the Leesburg Executive Airport North End Development Site Preparation (Construction) project, the sponsor intends to upfront most of the federal share and reimburse itself with 2 years of Bipartisan Infrastructure Law funding. Staff recommended that the VAB award the 8 percent state share of the project with the contingency that only the matching funds for the first year will be placed under grant and that grant will be amended when the remaining federal share is placed under a federal grant.

For the Manassas Regional Airport Observation Road Relocation & Drainage Improvement (Construction) project, the sponsor intends to upfront most of the federal share and reimburse itself with 4 years of Bipartisan Infrastructure Law funding. Staff recommended that the VAB award the 8 percent state share of the project with the contingency that only the matching funds for the first year will be placed under grant and that grant will be amended in the succeeding years as the remaining federal share is placed under a federal grant.

12. Public Comment Period

Randy Burdette, Chairman

No public comments were offered.

13. Board Member Comments and Reports

Randy Burdette, Chairman

Region 2: Ms. Cox noted that her roundtable was informative and gave her an appreciation for difficulties achieving contractual entitlement plan goals with regard to supply chain issues, worker shortages, and competition with more lucrative efforts that creating delays for project completion. She encouraged the department to be flexible to assist airports to be abel to take advantage of generous funding and complete projects.

Region 3: Mr. Hall stated it was a great meeting. Two concerns from the roundtable were: 1)the need for more forward leaning posture from the department in assisting airports in finding and retaining manpower and talent; and 2) the *Airport Program Manual* be more succinct regarding emerging technologies and sustainability. He recognized Louisa for sponsoring a teacher's attendance at an AOPA conference to participate in a track for teachers to encourage outreach to kids at a young age.

Region 4: Mr. Abbott reference Mr. Hall's comments as they co-hosted the roundtable. He added that Richmond Int'l Airport is seeking STEM recruitment through the high school. Another concern is potential issues aging pilots being able to obtain insurance.

Region 5: Ms. McLeskey noted airport concerns pertaining to the economic impact of hangars, drones, and UAV. She thanked platinum sponsors, sponsors and exhibitors and stated she was looking forward to visiting the airports in Region 5.

Region 6: Mr. Robertson echoed sentiments and thanked the participants for their candor and information. He noted the need for additional attention to the infrastructure required particularly for the smaller airports. He mentioned these may be aligned with efforts discussed by Dr. Wilson. He encouraged the involvement of smaller airports. He noted the importance of continued support for smaller airports and long-term sustainability as these changes evolve.

Region 7: Ms. Christie expressed appreciation for the conference coordination efforts. She agreed their candor was refreshing and a lot of dialog tied to Advanced Air Mobility. She encouraged the sharing of information in an effort to bring Virginia to the forefront for eVTOL and drone friendly. She noted a new route from Newport News to Florida. She thanked former Chairman Rod Hall for his leadership and welcomed Chairman Burdette.

Chairman: Mr. Burdette stated that he looks forward to working with Greg Campbell. He encouraged airports to keep the department informed. He encouraged VAB members to visit the airports in their regions. He noted exciting issues ahead. He stated that there will be a review of the *Airport Program Manual*. He wants to see all airports, regardless of size, grow.
